Resolutions were made on all the agenda points

- 1) Discussion on Lift AMC further Progress after Finalization on Johnson lifts: As per recent inspection on 25 -Apr-2023 one more VVVF, inevitable change required for D3 Lift. So its resolved to pay the 1<sup>st</sup> QTR payment with an amount of 9,60,141, Spares 1<sup>st</sup> instalment with an amount of 3,68,223 along with 4 VVVF payments for the 3 Blocks of 4 floors and 1 block of 10 floor lifts for an amount of 2,48,000 to be paid for Johnson Lifts Private limited for the year 1<sup>st</sup>May 2023-30<sup>th</sup> April 2024.
- 2) Discussion on AMC for OTIS Lifts: Resolved to go ahead with the best quote provided for the OTIS lifts.
- 3) Discussion on Security Agency Service: Resolved to go ahead with JAWAN Security Agency after detailed discussion and further process of Action Plan will be discussed in 15 days for further action plan with Advisory Security committee and Jawan Security Agency.
- 4) Resolved to Purchase Cameras inside and Outside the office for security reasons and as well as to purchase the additional Security cameras at the Gates.
