1. 3. Resolved to go for fencing for the borders of U 2 as per survey done STFOWA. If Pallavi people don't agree as per the border of survey land, then STFOWA will pursue it.

5. Resolved to give permission for Thimmappa tea stall from morning 6 AM to 9 PM as per paid Rs.6000/- monthly amount. He needs to remove if STFOWA says to remove. Panipuri Rs. 6000/- per month at C 3 till 10 pm.
6. Expenditure from 01-02-2024 to 23-02-2024 are approved.
7. Resolved to collect rents for the rooms occupied by owners as an amount of Rs. 3000/- or it will be vacated.
8. Resolved to give A 20 room for Amulya for a rent of Rs.3000/- prepaid rent every room.
9. All iron shops occupied rooms should pay 3000 per month who occupied.
