The 38th Executive Committee Meeting on Saturday 11-05-2024 at 10:30am at association office. The following resolutions were adopted unanimously.

Resolutions were made on all the agenda points

1. Approved the expenditure from 27-04-2024 to 09-05-2024 for 29,56,692/-
2. As decided earlier EC meeting for roof top water proofing painting work completed for C 10, A 19, A 27 payment is released to JVR Infra as per previous agreement.
3. As we are installing solar panel on ground level of G 4 area, information letter to be sent to Municipal Commissioner and Housing Board. Approach Banks for solar project finance till 20th May and if none of the banks approved loan, We will fund for the project from withdrawal of our Bank accounts or by break FD.
4. Resolved to approve 3 lakhs extra for AB 36 park renovation apart from the expenditure already completed around 68,000/-
5. Approved 20000/- for spray painting for AB 36 park items.
6. Approved to sale unused ladder lying since year at block A 20 at Rs.32/- per kg (scrap).
7. Approved the quotation of 45,145/- for HDPF pipes & flanges material.
8. Approved to purchase 50 dust bins.
9. Resolved to do repair for STP room fencing protecting sheets, window grill etc.
10. Approved Rs.1 lakh to purchase plastic chairs.
11. Approved to continue pay salaries to all religious places as decided in GBM.
12. Resolved to approve 5% enhancement on base price of Rs. 33,10,830/- for Johnson Lift, AMC for the period 1st May 2024 to 30th April 2025 + GST extra 18% on total final amount after negotiation with Johnson team.
