Subject: Conclusion of STFOWA Elections and Handover to STFOWA Executive Committee (2024-2026)

Dear Flat Owners,

Greetings from the STFOWA Election Committee (2024-2026)!

We are pleased to inform you about the successful conclusion of the STFOWA elections and the handover of responsibilities to the newly elected STFOWA Executive Committee for the term 2024-2026.

First and foremost, we extend our heartfelt gratitude to all flat owners for entrusting us with the responsibility of conducting this election. The decision taken during the 18th General Body Meeting (GBM) to form a three-member Election Committee comprising Shruti, Sai, and Rafi has been instrumental in this process.

We sincerely thank all the owners who actively participated in the elections. With your support, we successfully conducted the election process, including polling and counting, on 22nd December 2024.

However, due to rare and unforeseen circumstances arising from one closely contested vote, disputed and invalid votes for the post of President and Vice President, we were compelled to carry out a revalidation/recount of the disputed votes today i.e. 29.12.2024 to ensure fairness and transparency. We further made sure that notices are issued to all the contesting candidates for the post of President and Vice President by way of what's app and e-mails and sufficient publicity is made in order to bring to the notice of the contesting candidates that recounting is being carried for the said post today to enable the presence of the contesting candidates at the counting centre.

It was further made clear in the "*Terms and Conditions for Recounting or Revalidation of Disputed votes of Presidential and Vice Presidential posts*" under the caption for Timelines and Grace Period that the contesting candidates for President and Vice President post need to be present at the counting centre by 2:30PM, failing which further grace period would be granted by 3:00PM. Thereafter the election committee shall proceed with the counting process irrespective of presence of contesting candidates. We categorically mention that sufficient opportunity and notices are issued to

all the interested persons, so as to see that no candidates approaches the Hon'ble Court on ground of violation of Principles of Natural Justice and proceeded with the counting process in the larger interest of flat owners. flat owners the recounting process was carried.

Today, we concluded this revalidation/recount and are declaring the full and final results, as detailed in Annexure 1, which includes the total votes polled for all candidates. The voter slips dropped in the postal ballots by the voters will be disposed of after a week or 7 daysp for the safety and security of the voters.

Despite facing tremendous pressures, warnings, and even threats, we are proud to have completed the election process transparently. This achievement was made possible with the invaluable assistance of the police personnel and the media, who stood by us throughout. We extend our special thanks to the police department for their unwavering support in maintaining law and order and ensuring a smooth process.
